To Whom It May Concern:

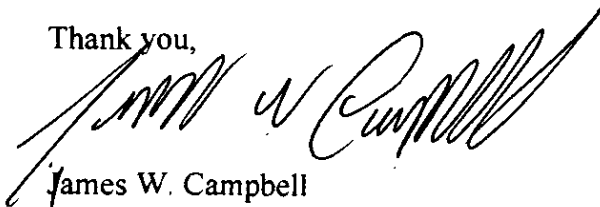
This letter will explain why this UBR form is late.
