**ARTICLES OF AMENDMENT OF
THE ARTICLES OF INCORPORATION OF

Article I of the Corporation's Articles of Incorporation is deleted in its entirety and the following is substituted in its stead:

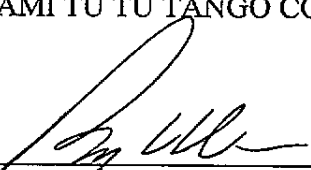
The name of the Corporation is **Miami Tu Tu Tango Corp.**
