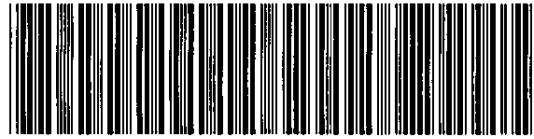

ARTICLES OF DISSOLUTION  
OF

**ONIC-CITY WATER, INC.,**  
a Florida corporation

Pursuant to §607.1403, *Florida Statutes*, ONIC-CITY WATER, INC. executes and files these Articles of Dissolution.

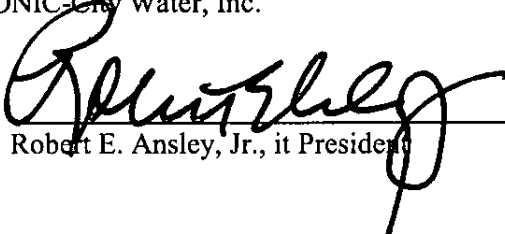
1. The Name of the Corporation is **ONIC-CITY WATER, INC.** The Corporation was incorporated on December 13, 1990.
2. The dissolution of the Corporation was authorized on January 9, 2007 and becomes effective on the date of these Articles of Dissolution..
3. The Corporation was the sole General Partner of FOREST EDGE, LTD., a Florida limited partnership and conducted no other business.. Effective as of the Effective Date hereinafter set forth, the Corporation assigned and transferred all of legal and beneficial right, title and interest in and to the General Partnership Interest of the Corporation to ONIC-Forest Edge GP, LLC, a Florida limited liability company, and ONIC-Forest Edge GP, LLC assumed all of the commitments, agreements, and obligations of the Corporation, as the sole General Partner of Forest Edge Ltd. pursuant to the the limited partnership agreement of Forest Edge, Ltd, as from time to time amended. The Effective Date, for all purposes and in all respects, was January 1, 2007 at 12:01 a.m. instantaneously after (A) that certain Assignment of Partnership Interest of the limited Partnership Interest in Forest Edge, Ltd. by and between Enterprise Housing Partners II, LP, a Maryland limited partnership and ONIC-Forest Edge LP LLC, a Florida limited liability company and (B) the Second Amendment to the Amended and Restated Agreement of Limited Partnership Of Forest Edge, Ltd..by and among City Water, Incorporated, a Florida corporation for profit (General Partner), ONIC-Forest Edge LP, LLC, a Florida limited liability company (Substituted Limited Partner) and Enterprise Housing Partners II, LP, a Maryland limited partnership (Withdrawing Limited Partner) each become effective and operational.
4. Orlando Neighborhood Improvement Corporation, Inc., a Florida corporation not for profit, is the sole and managing member of ONIC-Forest Edge GP, LLC. Prior to the authorization of the dissolution of the Corporation and at its regular meeting duly called and held on January 9, 2007, at which a quorum was present, the Board of Directors of Orlando Neighborhood Improvement Corporation, Inc., by a unanimous vote, ratified the aforesaid assignment/transfer to and assumption by ONIC-Forest Edge GP. LLC.
5. Orlando Neighborhood Improvement Corporation, Inc. is the sole shareholder of the Corporation. By a unanimous vote of the Board of Directors of Orlando Neighborhood Improvement Corporation, Inc., at its regular meeting duly called and held on January 9, 2007, at which a quorum was present, the dissolution of the Corporation was approved. There are no voting shareholder groups of the Corporation.

6. At the time the dissolution of the Corporation was authorized, the Corporation had no assets and had no debts of any nature or kind.

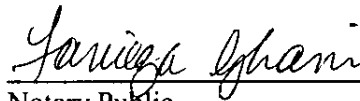
