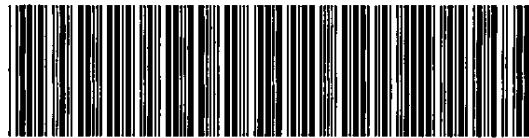



COMPLETE ALUMINUM & SCREEN, INC.




1. Article I is amended to read as follows:
