ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SNACKWORKS, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, Snackworks, Inc., a Florida corporation (the "Corporation), adopts the following Articles of Amendment to the Articles of Incorporation effective September 3, 2024 (the "Effective Date").

A. Article 1 of the Articles of Incorporation is deleted in its entirety and replaced as follows:

ARTICLE I NAME AND ADDRESS

The name of this corporation shall be LJL Saunders Road Partners, Inc. The physical and mailing address of the Corporation's principal office shall be at 3705 62nd Street E, Bradenton, FL 34208.

- B. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged and in full force and effect.
- C. The foregoing amendment was approved and ratified by a vote of the Board of Directors and the Shareholders effective September 1, 2024 in accordance with Section 607.1003 of the Florida Statutes and the Corporation's Bylaws.
