

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF VISTA SATELLITE COMMUNICATIONS, INC.

Pursuant to Section 607.1007 of the Florida Business Corporation Act (the "FBCA"), the undersigned corporation, VISTA Satellite Communications, Inc. (the "Corporation"), a Florida corporation, desiring to amend and restate its Articles of Incorporation, does hereby certify:

- 1. Articles of Incorporation of the Corporation were filed with the Secretary of State of Florida on December 19, 1990 under Document Number S19590.
- 2. The Board of Directors of the Corporation (the "Board") duly adopted the below Amended and Restated Articles of Incorporation by unanimous written consent on March 1, 2021.
- 3. The sole shareholder of the Corporation approved the below Amended and Restated Articles of Incorporation by written consent on March 1, 2021, which such consent was sufficient for approval.
- 4. The text of the Articles of Incorporation, as previously amended, are hereby amended and restated as herein set forth in full and shall supersede the original Articles of Incorporation and any amendments thereto.

ARTICLE I

NAME

The name of the corporation is VISTA Satellite Communications, Inc.

ARTICLE II

PRINCIPAL OFFICE

The street address of the current principal office and mailing address of the Corporation is 73 Southwest 12th Avenue, Suite 104, Dania Beach, Florida 33004. The Corporation siprincipal office may be relocated, within or outside the State of Florida, from time to time as determined by the Board.

<u>ARTICLE</u> III

PURPOSE

The Corporation is organized to engage in any lawful act or activity for which corporations may be organized under the FBCA.

ARTICLE IV

AUTHORIZED SHARES

The total number of shares that the Corporation is authorized to issue and have outstanding at any time is 1,000 shares, all of which shares shall be Common Stock, par value \$0.01 per share.

ARTICLE V

INITIAL DIRECTORS

The number of directors which shall constitute the whole Board shall be fixed by, or in the manner provided in, the bylaws of the Corporation.

ARTICLE VI

TERM

The term of existence of the Corporation is perpetual.

ARTICLE VII

REGISTERED OFFICE AND AGENT
