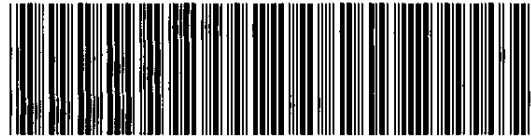

Adoption of Dissolution




