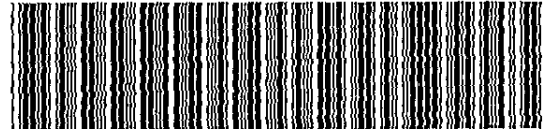

1. The name of the Corporation is **FIRST FLORIDA REAL ESTATE CONSULTANTS, INC.** (Florida Document No. S20015).


