

**ARTICLES OF DISSOLUTION  
PURSUANT TO SECTION 607.1403  
OF THE  
FLORIDA BUSINESS CORPORATION ACT**

Pursuant to the provisions of Section 607.1403 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is:

**SIGTEC AMERICA, INC.**

2. The Corporation was incorporated on December 19, 1990, and assigned document number S20193.

3. Pursuant to the Corporation's Dylaws, a simple majority of the Shareholders is required to dissolve the Corporation.

4. Pursuant to Section 607.0704 of the Florida Statutes (1997), the Sole Shareholder, in an action taken by written consent effective September 22, 1998, approved the dissolution of the Corporation.

5. Pursuant to the above referenced consent of the Sole Shareholder, the officers of the Corporation are hereby authorized and directed to file these Articles of Dissolution with the Secretary of State.

6. The Corporation shall be dissolved effective September 30, 1998.
