Highlands County's 911 Emergency Telephone System Improves emergency response for Police, Fire and Ambulance. The **PHYSICAL SITE ADDRESS** at which you reside or own property will be changed as noted above. We recommend that you post this new number with 4" or 6" numbers for Residential or Commercial respectively, in a contrasting color on the assigned dwelling. Failure to display it could result in delays in mail delivery and response by emergency vehicles. Highlands County will notify this Post Office, Police, Utility Companies, Sprint Telephone Company, Fire and Ambulance Service that government records pertaining to the physical site address for your property has been changed. All you need to change is your mailing address on your personal mail.

The Post Office will deliver mail to the old addresses for **ONE YEAR** giving you time to notify all agencies.

This address does not mean you cannot use a Post Office, Box within a Post Office, or a central mailbox within a Mobile Home Park or Condominium.

The Post Office will continue to deliver mail addressed to your old number/street name for a period of time to allow you to change your address with minimum of inconvenience.
