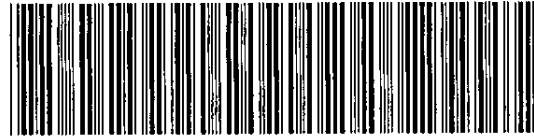

The name of the corporation is Stephens, Lynn, Klein, La Cava & Puya, P.A. The document number of the corporation is S21719.


The effective date of the dissolution that is being revoked was June 1, 2010.


