

The name of this corporation is THE CRAMER UNZICKER LAW FIRM , P.A. The duration of the Corporation shall be perpetual.


3. The foregoing Amendment to Articles of Incorporation was duly adopted by unanimous consent of the stockholders and board of directors on September 22, 1997.
