On Friday, October 13, thanks to the initiative of a mail carrier who knew we had moved, we received a Notice of Administrative Dissolution or Revocation. We presume that we received this notice because we did not file an Annual Report in a timely fashion. We did not file an Annual Report because we did not receive an Annual Report Form. This was due to the fact that both the original form, I presume, and this Notice were mailed to the wrong address. We moved our offices to 2901 Cardinal Dr., Vero Beach in April 1999.

Had we received the Annual Report Form, it would have been filed in a timely fashion, as it has been in past years. I know that the State of Florida has our correct address as we file reports such as sales tax, workers' compensation and unemployment compensation regularly. I light of the above, we are upset that the State does not know our whereabouts and unfairly expects us to pay a \$600.00 Reinstatement Fee. We, therefore, request that the penalty be rescinded.

In order to show our good faith, pending the outcome of your deliberations, we obtained a 2000 Annual Report Form from our attorneys and are returning the completed form to you along with our check in the amount of \$150.00 which we understand is the fee that we would have paid, had we received and filed the Annual Report prior to May 1, 2000.
