We are late unbeknownst to me. I thought this had been paid. Until recently, I had no reason to believe I hadn't. I assure you had I known I would have mailed it out immediately. My Tax Lady had brought it up and I had told her "yes I had paid it!", until I went and looked for proof and I couldn't find any. I then called you to see what your records showed and the nice lady said I didn't show as paying. I have never been late in all the years since 1990 so please accept this explanation as to why.

I was in a severe car wreck on September 29, 1999, with severe multiple injuries.

I died and was on life support for one month. I broke both my arms, one leg, my jaw in three places, lost a child, and have a severe brain injury. My Brain injury has greatly affected my memory and thinking ability. I forgot to pay my mortgage payment, car payment, and many other bills, so I now know I cannot trust my mind. I have not returned to work as of yet. Due to the fact that I am the only one who has ever taken care of the accounting and billing for my husband for the last 13 years. Please accept my sincerest apology for any past due bills due to the above facts. I would appreciate greatly your understanding.

I am sending 150 \$ which is all I can send right now, with much difficulty. Please consider my plea and see if you can waive any of this large late fee. I am struggling financially. My hospital bills are all on my back since they have gone to collections I am only paying a little at a time to some of the people. I am not working since my car wreck and have no visible income at present. My husband who had never done any of our inner office duties, was unable to do any receivables, payables, payroll, collecting, nor knew how to use the computer and is at a complete loss. He stayed by my side while I was on life support which also was detrimental to his business. I now am home but, unable to pay for the hospital bills, extended care, multiple surgeries, bills caused by the business, living expenses, nor our personal bills. I am asking for your special consideration in our poor situation to do whatever is within your power to help. I have applied for disability but they said it takes 6 months. My home has a lien on it by three parties, the first mortgage, the second we lent the business, and Shands Hospital in Gainesville for more than it is worth. We have had it on the market to sale since December of 1999 with no buyers at this point. I am almost homeless. I am only alive by the grace of God.
