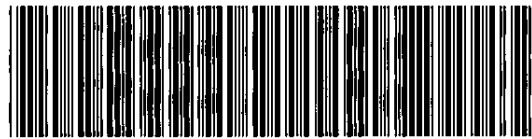



Pursuant to Section 607.1403, Florida Statutes, we, the undersigned, hereby execute, acknowledge and file the following Articles of Dissolution for the purpose of recording the dissolution of Glodex, Corp., a Florida corporation for profit organized under the laws of the State of Florida, to wit:

ARTICLE I - Name and Incorporation

The name of the corporation is Glodex, Corp. (the "Corporation"), that was incorporated under Articles of Incorporation filed with the Florida Department of State on January 18, 1991 and assigned document number S25916.

ARTICLE II-Resolutions of the Shareholders

The sole shareholder and the board of directors of the Corporation by a unanimous written consent dated May 28, 2010 decided to authorize the dissolution of the Corporation.

The effective date of the dissolution of the Corporation shall be as of May 31, 2010.


ARTICLES III-Shareholders Vote.
