**ARTICLES OF DISSOLUTION**

Pursuant to Section 607.1403, Florida Statutes, **Search International, Inc.**, a Florida corporation (the "**Corporation**"), submits the following Articles of Dissolution:

**ARTICLE I**

The name of the corporation is **Search International, Inc.** The document number for the Corporation is S27896.

**ARTICLE II**

The voluntary dissolution of the Corporation is authorized as of December 31, 2014.

**ARTICLE III**

The dissolution of the Corporation was approved by the shareholders of the Corporation holding a majority of the issued and outstanding stock of the Corporation entitled to vote.

**ARTICLE IV**
