SECOND ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF BAYCARE HEALTH NETWORK, INC.



The undersigned hereby desires to amend the Articles of Incorporation of Baycare Health Network, Inc., a Florida corporation, as heretofore amended, in accordance with Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, and hereby states as follows:

I.

The name of the corporation is Baycare Health Network, Inc. (the "Corporation").

(A) Article VI, Section 3 (General Quorum and Voting for Directors) of the Articles of Incorporation shall be amended in its entirety to read as follows:

A quorum of the Board of Directors shall consist of any ten (10) directors; provided however that of the ten (10) directors there must be two (2) directors (Physician or Hospital Directors) from each of five (5) out of the seven (7) Class A and Class B Shareholders present at the meeting to constitute a quorum.
