ARTICLE III

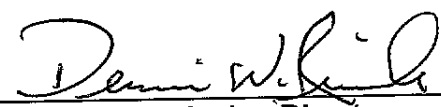
The corporation known as INTERNATIONAL COST CONTAINMENT NETWORK, INC., shall be dissolved effective December 31, 1998.
