TO
ARTICLES OF INCORPORATION

Pursuant to Section 607.187(1), Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST

The name of the corporation is: **TRIDENT HOSPITALITY (ORANGE) INC.**

SECOND

The following amendment to the Articles of Incorporation was adopted by the Corporation:

ARTICLE III. NATURE OF BUSINESS

"The purpose for which TRIDENT HOSPITALITY (ORANGE) INC., is organized is limited solely to (a) owning, holding, selling, leasing, transferring, exchanging, operating and managing the motel complex located at 3810 S. Washington Avenue, Titusville, FL 32781; (b) financing and refinancing said motel complex; and, (c) transacting any and all lawful business for which a corporation may be organized under the laws of the State of Florida that is incident, necessary and appropriate to accomplish the foregoing. P & S Investments, Inc., shall not commingle its assets with those of any other entity."

THIRD
