The authors also note that the results of the regression analysis indicate that the dependent variable, the average annual corporate tax rate, is significantly affected by the population of the corporate tax jurisdiction. The results indicate that the average annual corporate tax rate is higher in jurisdictions with a larger population. This finding is consistent with the hypothesis that larger jurisdictions are able to attract more corporate tax revenue and, therefore, are able to maintain a higher average annual corporate tax rate.
