To Whom it May Concern,


I called your office yesterday and discussed with them the problem I had with respect to non-filing of the annual corporate report and fees. They advised me to send this letter and explanation of the facts, along with the check for \$315.00 for 1997 and 1998 corporate fees.

This past year I spent away from home in Russia where I am establishing an office for my Florida corporations. The mail was being forwarded to me there, but I never received the original or subsequent notices or reports in early 1997 to file annual fees. The enclosed form which was sent by your office in September or October 1997 only reached my Moscow address by Russian mail in late January 1998.

I have always paid my bills for this corporation and am respectfully requesting that the penalty fees be waived and the corporation be restored. We are very small operation and funds are very tight.
