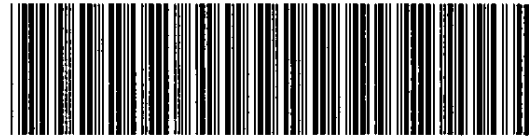



Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced as follows:


