The undersigned, being the President and Vice President of ORIDA Waldman & Feluren, P.A., (the "Corporation"), for the purpose of amending the Articles of Incorporation, pursuant to Florida Statutes Section 607.1001, so as to change the name of the Corporation, does hereby certify as follows:

- 1. The name of the Corporation is Waldman & Feluren, P.A.
- 2. The Articles of Incorporation of the Corporation are hereby amended by deleting Article FIRST thereof in its entirety and by substituting in lieu thereof the following new Article FIRST:

"FIRST: The name of the corporation shall be Waldman Feluren & Trigoboff, P.A."

3. The aforesaid Amendment was adopted on January 28, 1998 pursuant to a written statement and consent signed by all shareholders of the Corporation. The Corporation has less than 35 shareholders. The action by the shareholders constitutes a number of votes sufficient for approval.
