Following the twin hurricanes that passed through Indian River County this past September, we were working with our insurance company to finalize damages. We were alerted that FMK of Vero Beach, Inc. was listed as wactive in Florida, to which we were puzzled and in disbelief.

We asked our new CPA firm to look into the matter and they found that our corporation was deemed inactive, by administrative dissolution for annual report, on October 4, 2002. We have no idea how this was missed and have no recollection of having received correspondence at any time regarding the matter. Our former CPA, which was disengaged in 2002, was not the registered agent, so correspondence was not mailed to his office.

In any event, we wish to be immediately re-instated and are filing Form CR2E081, Corporation Reinstatement. The instructions dictate that we remit \$1,050, plus \$8.75 for a certificate of status, for reinstatement. However, we respectfully request that any waiver of fees be considered for our reinstatement. Internal changes and change of outside accounting firms at the time of the dissolution obviously contributed to the missed filing, as evidenced by the fact we had timely filed prior to that date since our inception. Further, due to the damages and lost business suffered as a result of Frances and Jeanne passing through our area, the enclosed remittance is causing a hardship.

We thank you in advance for your kind attention to our case and look forward to your reply.
