United Community Management Corp. (the "**Corporation**"), a corporation organized and existing under and by virtue of the provisions of the Florida Business Corporation Act of the State of Florida (as amended from time to time, the "**Act**").

DOES HEREBY CERTIFY:

1. That the Corporation filed a Certificate of Incorporation (the "**Original Certificate of Incorporation**") with the Secretary of State of the State of Florida on April 11, 1991.

2. That the Corporation adopted and filed an Amendment to the Original Certificate of Incorporation with the Secretary of State of the State of Florida on February 3, 1997 (the "**Amendment to Certificate of Incorporation**").

3. That the Corporation adopted this Amended and Restated Certificate of Incorporation on March 31, 2022 (this "**Amended and Restated Certificate**"). This Amended and Restated Certificate was approved by the shareholders. The number of votes cast for this Amended and Restated Certificate, were sufficient for approval. The Original Certificate of Incorporation as amended by such Amendment to Certificate of Incorporation and this Amended and Restated Certificate of Incorporation, are collectively referred to herein as the "**Certificate of Incorporation**".

FIRST: Name. The name of the Corporation is United Community Management Corp.

SECOND: Principal Place of Business. The principal place of business address and mailing address of the Corporation is 11784 West Sample Road Coral Springs, FL 33065
