We the undersigned directors certify that we constitute a majority of the BORGASSEE, FLORIDA Directors of the aforementioned Corporation, formed pursuant to the provisions of the laws of the State of Florida, that we have adopted the following amendments to the Articles of Incorporation of said Corporation: Somark International Inc.
