We enclose herewith the following with respect to reinstatement of the above-noted Corporation:

1. In duplicate, Corporation Reinstatement form, duly completed and executed;
2. Cheque made payable to the Department of State in the amount of \$458.75 (\$150.00 x 3) representing the annual report and corporate supplemental fee for each of the years 2004, 2005 and 2006 PLUS \$8.75 for a Certificate of Status;
3. Cheque made payable to the Department of State in the amount of \$1,050.00 (year dissolved was 2004), which cheque is provided under protest. We request that the reinstatement fee be waived in circumstances where the corporation did not receive the annual report notices in the year of dissolution. We note from a corporate search that the mailing address is incomplete. The absence of a postal code, we believe, resulted in non-delivery of the annual report, if in fact the Department attempted delivery to that address. In addition, we note that the officer's address is incomplete AND incorrect as it identifies the street as PINEWOOD (should be Penwood) and, again, has no postal code. As a result of the foregoing, we request your indulgence in waiving the reinstatement fee and returning the enclosed cheque in the amount of \$1,050.00 to the writer.
