Corporation Name: GC-GW, Inc.

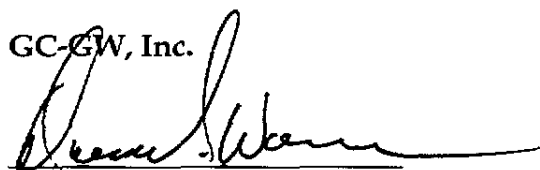
Date dissolution authorized: November 7, 2002

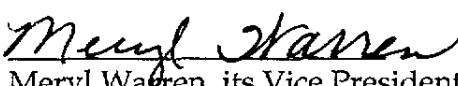
Dissolution was approved by the shareholders. The number of votes case for dissolution was sufficient for approval.
