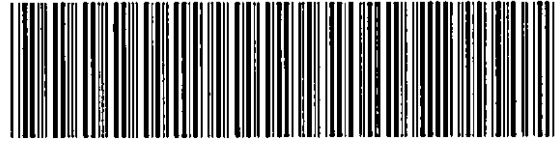

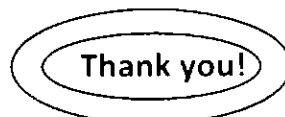

ARTICLE I. NAME

The name of this corporation is Managed Care of North America, Inc.

ARTICLE II. CORPORATE EXISTENCE

The duration of the corporation shall be perpetual.

ARTICLE III. PURPOSE

The purpose for which the corporation is organized is to engage in any lawful act or activity for which corporation may be organized under the Florida Business Corporations Act of the State of Florida.

**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
MANAGED CARE OF NORTH AMERICA, INC.**

Pursuant to Section 607 of the Business Corporation Act of the State of Florida, the undersigned, being an authorized officer of Managed Care of North America, Inc. (hereinafter the "Corporation"), a Florida Corporation, desiring to amend its Articles of Incorporation does hereby certify:

FIRST: These are the Amended and Restated Articles of Incorporation of the Corporation, with a desired effective date of February 1, 2023.

SECOND: The Corporation filed its original Articles of Incorporation with the Secretary of State on May 3, 1991; Articles of Amendment were thereafter filed on November 12, 1991, November 7, 2007, and April 25, 2008.

THIRD: These Amended and Restated Articles of Incorporation, which supersede and replace the original Articles of Incorporation and all amendments thereto, were adopted by the Board of Directors of the Corporation, pursuant to Section 607.1002 of the Florida Business Corporation Act on February 1, 2023.

The amendment(s) was/were adopted by the incorporators, or board of director without shareholder action and shareholder action was not required.
