Pursuant to Sections 607.1402 and Section 607.1403 of the Florida Business Corporation Act (the "Act"), this Florida profit corporation submits the following Articles of Dissolution:

Article I

The name of the corporation as currently filed with the Florida Department of State is LAYNE D. NISENBAUM, D.O., INC. (the "Corporation").

Article II

The document number of the Corporation with the Florida Department of State is S50759.

Article III

The original file date of the Articles of Incorporation for the Corporation was May 8, 1991.

Article IV

The dissolution of the Corporation was authorized by written consent of the sole director and sole shareholder of the Corporation dated February 13, 2013, pursuant to Sections 607.0821 and 607.0704 of the Act.
