Pursuant to the provisions of Section 607.1006, Florida Statutes, FEASINOMICS, INC., a Florida corporation, Florida registration number S51249, adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** Article I is hereby amended as follows:

**ARTICLE I  
CORPORATE NAME**

The name of the corporation shall be MJT CAPITAL GROUP, INC. (the "Corporation").  
The address of the principal place of business is 6556 Chestnut Circle, Naples, FL 34109.

**SECOND:** The amendment was approved by the directors and shareholders of the corporation on May 17, 2006, by unanimous vote of all the shares of the corporation entitled to vote.
