Dear Department:

My client, Deland Central Medical Associates, Inc. a for profit corporation in the State of Florida, was, unfortunately administratively dissolved for failure to file their 2003 Uniform Business Report.

This corporation **moved their location and changed their mailing address** in the year 2002 and their mail forwarding had expired prior to your sending their renewal and late notice for their 2003 UBR. They were prudent in filing Form 8822 Change of Address at the time of moving, however, they were unaware this notice was only for notification to the Internal Revenue Service and not to the State of Florida.

I discovered their "administratively dissolved" status upon the Corporation's Presidents request that I file their 2004 UBR on line.

I have discussed this matter with the corporation's Board of Directors and was immediately authorized to notify your office of the Board's complete cooperation, sincerity, and swift willingness to come into total compliance.

The NONRENEWAL of the corporation's 2003 UBR was most UNINTENTIONAL and due only to the moving of their location and expiration of mail forwarding. Investigation did reveal that the owner of the building previously leased by this

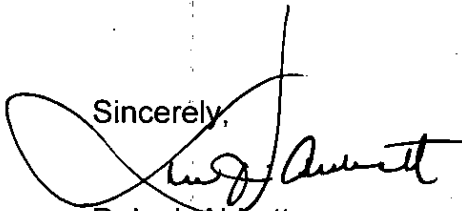

Corporation, DID NOT and WOULD NOT forward mail delivered to the premises subsequent to the corporation vacating the property. Thus, no receipt of renewal from the Department of State.

As the corporation's non renewal of their 2003 UBR was due to unforeseen circumstances and unintentional, I would like to request a REINSTATEMENT and waiver of the penalties involved in this process. Enclosed you will find a check in the amount of \$150.00 for their 2003 UBR and a check in the amount of \$150.00 for their 2004 UBR which could not be renewed prior to May 1, 2004 due to the 2003 dissolution. A fully executed corporate reinstatement form is enclosed for 2003. I would like to request you provide me with the 2004 UBR for filing (prepaying with this letter) and I will obtain the necessary signatures.

Your cooperation in this matter is most appreciated. Deland Central Medical Associates, Inc. has been a long standing Florida Corporation and has always timely filed their reports. The 2003 omission was certainly unintentional.
