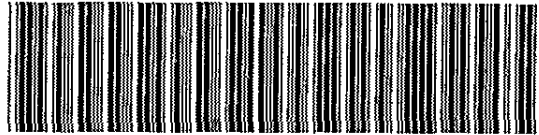




1. Article 1 of the Articles of Incorporation of Spohrer, Wilner, Maxwell & Matthews, P.A. is amended to read as follows:

2. The foregoing amendment was adopted by the shareholders of this corporation by unanimous vote of all shareholders on Oct 10th 2006.


