The name of the Corporation is QUINCY JOHNSON, JONES, MYOTT, WILLIAMS, ACEVEDO, VAUGHN ARCHITECTS, INC., a Florida corporation (the "Corporation"), filed with the Florida Department of State on May 16, 1991 under document number S53290. Pursuant to the provisions of Section 607.1006, Florida Statutes, the Corporation adopts the following amendment to its Articles of Incorporation:
