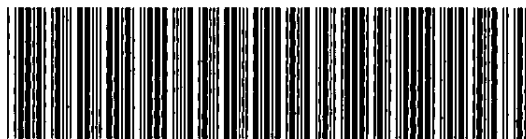

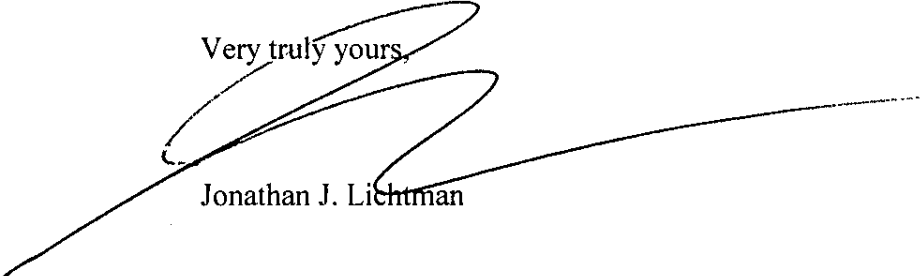

1.
