


1. The Articles of Incorporation of CASEY AND MOLCHAN PROFESSIONAL ASSOCIATION are amended by adding a new Article VII as follows: \_\_\_\_\_


**ARTICLE VII - PRACTICE OF LAW IN COLORADO**

With regard to the practice of law in Colorado, each shareholder of the Corporation who is a shareholder at the time of the commission of any professional act, error or omission by any of the shareholders, officers, directors, or employees of the Corporation shall be jointly and severally liable to the extent provided by Rule 265 of the Colorado Rules of Professional Conduct for the damages caused by such act, error or omission; provided, however, that any such shareholder who has not directly and actively participated in the act, error or omission for which liability is claimed shall not be liable, except as provided in clause (e) of subparagraph I.A.4 of Rule 265, for any of the damages caused thereby if, at the time of the act, error or omission occurs, the Corporation has professional liability insurance which meets the minimum standards set forth in subparagraph I.A.4 of Rule 265.


2. The foregoing Amendment was adopted by written consent of all of the shareholders and directors of this Corporation on DECEMBER 8, 1998.
