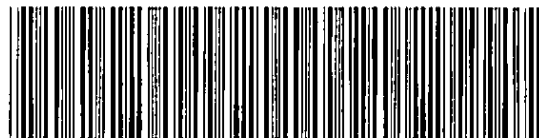


II. Article VII is hereby amended as follows:


"The corporation shall have a Board of Directors consisting of four (4) persons and may be increased to not more than five (5) directors."


The Articles of Amendment will be effective January 1, 2023.


The foregoing amendments were approved by all of the Shareholders and Directors this 1st day of January, 2023.




