The undersigned does hereby certify as follows:

- 1. He is the Vice President of Bocal Corporation, a Florida corporation, whose original Articles of Incorporation were filed with the Department of State on May 29, 1991, and amended by Articles of Amendment to Articles of Incorporation dated June 10, 1998 and filed with the Department of States on June 11, 1998 ("Articles of Incorporation").
