**Article 4.** The corporation has only one class of stock.

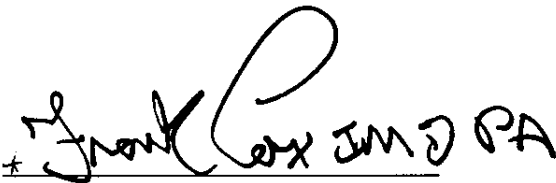
