Y.Z. Enterprises is a one-man corporation, and as a traveling salesman, I spend much of my time out of the country. I received your second notice about paying the registration fee of \$150 plus the \$400 late fee. I mailed that notice with a letter from my accountant requesting canceling of the late fee. My request was turned down. I called your office to talk to a supervisor. In response to my call, I received a new notice from your office with the instructions to write a letter stating that I didn't receive the first notice about registering my corporation. I wrote a letter stating the above and sent it with the late notice from your office.

About a week ago, I received this notice of dissolution of my corporation. I called again and was told to write a new letter and send it back with the dissolution notice, which is what I am now doing. Also attached is a copy of a cashed check (check #1936) for the original payment of \$150.

As I said before, this is a one-man corporation and a \$400 fine is a considerable burden. My records are in good condition and this is the first time that such a thing has happened. As a gesture of good will, I request for your office to reconsider my situation and the fact that I never received the first notice.
