Dear Kristen,

Enclosed please find a copy of the Profit Corporation Annual Report 1999 which was originally filed on May 7, 1999, along with our replacement check #2079 in the amount of \$550, as per your instructions and our telephone conversation earlier today.

As I explained in our telephone conversation, I worked for Perch in our St. Petersburg, Florida office. After ten years in Florida, my husband and I were finally ready for our long awaited move back home, to Alaska. After six years with my boss, Robert P. Gordon, my last day was to have been July 9, 1999. I continued to come in to the office a couple of times a week to assist and do some clean up. We had hired someone (April 14, 1999) to assume my responsibilities but after completing her probationary period, she decided to quit and left us suddenly (July 20, 1999). It was determined that I would continue my responsibilities and work from my home in Alaska. I packed up 13 boxes of files and headed on my way.

My husband and I had long dreamed of our drive back to Alaska and had purchased a motor home and trailer. Unfortunately, we encountered delays due to the motor home hitch and trailer needing modification as well as problems with the motor home generator. So, instead of leaving Florida on July 30 as we intended, we did not leave until August 10. We arrived in good order (amazingly!) late on August 26. Along the way, I worked on my laptop and received overnight packages from the Florida office. When I reconciled the bank account for Perch, I found it odd that our check to the State had not yet cleared. In addition, we received a second notice for the annual report. Sometime along the way, I called the State and verified you had not received the package. Apparently this return and payment have been lost in the US Mail. I was given instructions but they were not possible for me to accomplish at that time (from the motor home somewhere in Canada). We have lived in our motor home at a RV Park in Anchorage from August 26 until yesterday afternoon when we took occupancy of our home.

When I was bringing in the work from the motor home, I remembered this needed to be done and now have printer and copy capability. I called you today because I was concerned about the Sept. 15 deadline. I am very grateful for your assurances that Perch, Inc. will remain in good standing until you can process this report.
