

Pursuant to the provisions of Florida Statutes section 607.1006, this Florida profit corporation adopts these Articles of Amendment to its Articles of Incorporation.

FIRST: Amendments adopted: Article I of the Articles of Incorporation of ~~ITAC Corporation~~ International Taekwondo Alliance, Inc. is hereby amended and restated to provide in its entirety as follows:


ARTICLE I

The name of the corporation is S.M.A.R.T. Systems, Inc. The street address of the corporation's principal office is 33789 Southridge Road, Sioux City, IA 51104.
