Pursuant to the provisions of Section 607.1006(1) of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the Corporation is PAUL DAVIS SYSTEMS, INC. OF TAMPA WEST.

2. The following amendments to the Articles of Incorporation were adopted by the Shareholders of the Corporation on the 1st day of September, 2000, in the manner prescribed by the Florida Business Corporation Act:

Article I is hereby amended to read as follows:
