**AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
MR. GREENJEANS' PRODUCE, INC.**

Pursuant to Section 607.1007 of the Business Corporation Act of the State of Florida, the undersigned, being the sole Director of MR. GREENJEANS' PRODUCE, INC. (hereinafter the "Corporation"), a Florida corporation, and desiring to amend and restate its Articles of Incorporation, do hereby certify:

FIRST: The name of the Corporation is MR. GREENJEANS' PRODUCE, INC.

SECOND: The date of filing of the original Articles of Incorporation was July 2, 1991, document number S63732.

THIRD: On July 10, 1992, Timothy M. Sanders transferred his 50% ownership interest in the Corporation to Thomas L. Bauer, and on January 1, 2011 Thomas L. Bauer transferred his 100% ownership interest in the Corporation to Kimberly Bauer.

FOURTH: These Amended and Restated Articles of Incorporation, which supersede the original Articles of Incorporation and all amendments to them, were adopted by the sole Director of the Corporation on March 26, 2014. To effect the foregoing, the text of the Articles of Incorporation is hereby restated and amended as herein set forth in full:

**ARTICLE I.
NAME**

The name of the Corporation is MR. GREENJEANS' PRODUCE, INC.

**ARTICLE II.
PURPOSE**

The Corporation is organized for the purpose of the transaction of any lawful business for which corporations may be incorporated under the laws of the State of Florida.

**ARTICLE III.
DURATION**

The Corporation is to exist perpetually.

**ARTICLE IV.
CAPITAL STOCKS**

The Corporation is authorized to issue ONE HUNDRED (100) SHARES of the common stock of a par value of ONE (\$1.00) DOLLAR per share and the consideration to be paid for each share shall be fixed by the Board of Directors.

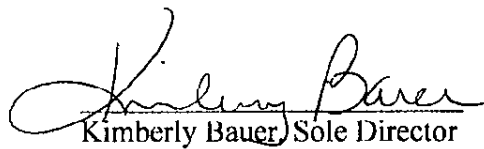
ARTICLE IX.
