~~We represent Gator Reman. We have been asked by our client to clear up some~~  
confusion regarding Gator Reman's 2001 Uniform Business Report and the administrative  
dissolution of the company.

Last May, Gator Reman forwarded its 2001 Uniform Business Report along with the  
\$150.00 filing fee to your office. A copy of the \$150.00 check, which was cashed on May  
17, 2001, is enclosed. In February 2002, Gator Reman learned for the first time that the form  
report was missing a necessary signature. By that time, based on the incomplete form, Gator  
Reman had been administratively dissolved. In its February letter, a copy of which is  
attached, the State required that Gator Reman file reinstatement papers and pay the  
associated filing fees.

According to a representative in your office, a notification letter was sent to Gator  
Reman on or around June 1, 2001. Unfortunately, Gator Reman did not receive that letter

Reman requests that the State reinstate its corporate status and waive all fees. Enclosed is
