## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF TRANSAIR SERVICES CORPORATION

Pursuant to the requirements of Sections 607.1003 and 607.1006, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Incorporation of TRANSAIR SERVICES CORPORATION (the "Corporation"), which Corporation was incorporated in the State of Florida on July 22, 1991, under Charter No. S67185:

1. The members of the Board of Directors of the Corporation have recommended the following proposed change to the Articles of Incorporation to the shareholders of the Corporation, and the shareholders of the Corporation have unanimously voted to change the Corporation's Articles of Incorporation as follows:

Article V of the Corporation's Articles of Incorporation shall be deleted in its entirety and the following inserted in its place:

## "ARTICLE V

The total number of shares of capital stock which the Corporation has the authority to issue is 2,000,000 shares of Common Stock ("Common Stock"), \$.01 par value per share."

- 2. All other provisions of the Corporation's Articles of Incorporation shall remain in full force and effect, unaltered except as expressly provided above.
- 3. The foregoing amendment to the Articles of Incorporation was unanimously adopted by all of the members of the Board of Directors and all of the shareholders of the Corporation effective as of the date hereof, and the number of votes cast for the amendment was sufficient for approval.
