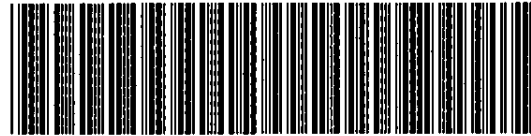

FIRST: The name of the corporation as currently filed with the Florida Department of State is Collier's Realty Group, Inc.


SECOND: The document number of the corporation is S67228.
