**ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION OF
SIMS WILKERSON ENGINEERING, INC.**

THE UNDERSIGNED, President of SIMS WILKERSON ENGINEERING, INC., a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is SIMS WILKERSON ENGINEERING, INC.

ARTICLE SECOND: The amendment to the Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE 1. of the current Articles of Incorporation is amended to provide as follows:

"ARTICLE 1. NAME: The name of the Corporation shall be SIMS WILKERSON CARTIER ENGINEERING, INC."
