Following the directions on the second page of the UBR for 2002, the Secretary of State Katherine Harris, encourages the business owners to use the Internet to file with the Florida Department of State. On April 23, 2002 we did so. A few days later, last Friday, when I called to verify that our submission was successful, I was horrified to find out that our submission was unsuccessful. I called the Florida Department of State to explain my situation. I was then told to send my regular \$150 filing fee and a letter explaining the reason we were late.

Amiga Insurance Agency Inc is a very small family business trying to survive these turbulent times. We have never asked for any kind of government assistance or grant for our very small business. In a world of large corporations, we struggle to survive in business every day. Even today's insurance industry is struggling to survive after the September 11, 2001 crisis. We feel the negative effects of this struggle on a daily basis in our small business.

Amiga Insurance Agency Inc, was incorporated back in 1991 and we have never been late in our filings with the state. A \$400 late fee penalty is an extremely severe penalty and would adversely affect us. We ask that you please have consideration with us. Please have compassion and understanding with us. We assure you that this situation will never happen again.
