2. Article I of the Articles of Incorporation of Independent Software Services, Inc., hereby is amended to read:

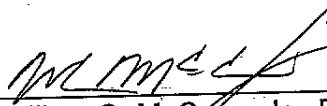
"ARTICLE I

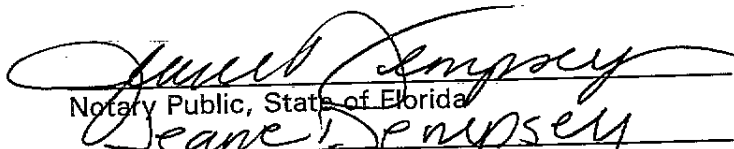
